The Benefits Tune-up Workbook, a self-audit tool to ensure care and compliance for staff, has emerged as one of the best-known resources of the Office of Church Staff Finances. We'll share its origin story and evolution, briefly review the basics, and spend some time answering your questions. But most importantly, we want to hear from you. How is the Benefits Tune-up Workbook working for you, as administrators? What are the obstacles to completing it? If you aren't engaging with it, why not? Can we make it more user-friendly for you and/or other leaders? What should we be thinking about for the 2025 edition?

#### May 22—AUUA Code of Ethics

Join AUUA Board President Christina Fulton and Vice President Karena Stroh in a conversation about how best practices guided the crafting of our updated Code of Ethics, presented at the 2023 Annual Meeting. Due to concerns about section III. D (see text below) from some of our members, we did not vote to accept this update.

Section III. D states: In the case of planned or forced resignation or significant change in role or responsibility, I will work with congregational leadership to execute a well-managed departure or change. Additionally, when leaving my position, I will covenant with my congregation's leadership to remain absent from all church activities for an agreed period of time to ensure a healthy transition.

We hope you will join us and lean into this conversation which will center how we, as religious professionals, can support healthy transitions.

# Professional Days 2024 ~ Advocating for Ourselves ~ Thursday, June 13

Professional Days 2024 will look a little different this year, and we hope it's a change that's going to help more administrators attend and help us find more balance in our work.

This year, rather than 2 full days of online trainings we are splitting the Professional Days program into two 1-day sessions. One will be held on June 13 with the theme **ADVOCATING FOR OUR-SELVES**. A second ProDays session will be held in October 2024 (date and theme to be announced).

In the broadest definition, self-advocacy is the ability to speak up for yourself. It's the ability to identify your needs, communicate them clearly, and help others understand how they can support you. We'll take time on this newly formatted Professional Days event to learn some self-advocacy skills, learn how to set clear boundaries and learn how to help our congregations see what a "right-sized" job looks like.

Along with self-advocacy work we'll also get to meet and hear from the Office of Church Staff Finances, have our Annual Business Meeting to approve the budget and elect Board members and have time to network together.

The UU Association of Membership Professionals (UUAMP) is comprised of both paid staff and volunteers serving UU congregations, who have membership as one of the main components of their ministry. Membership is just \$75\* a year and includes:

- Educational opportunities such as Book Discussion Groups and Webinars, Best Practice Seminars, and workshops including our Pro-Days.

In these venues, members can network, discuss our challenges and triumphs, swap resources, and enjoy a sense of community, fellowship and support from colleagues who share your vision and goal.
